Installation Instructions

1. INTRODUCTION

Detector's Features

- Patented 8 independent quad PIR detectors (Octa-PIR™) operating in true Quad configuration with true motion recognition (TMR) processing for each of the 8 PIR detectors and central motion processing - can distinguish between a moving intruder and moving trees and bushes.
- Advanced Obsidian Black Mirror™ optics (patent pending).
- Smart protection against snow, rain, dust, wind and direct sunlight.
- Tamper protection prevents opening and removal from wall.
- Alarm LED is visible in sunlight.

- Day & night or night only settings.
- Robust housing with recessed window.
- Smart anti masking can distinguish between masking spray and rain.
- Immunity to pets weighing up to 18 Kg (40lb), not pet alley.
- Built in swivel bracket.




Figure 1 - TOWER 20 AM MCW




Fig. 2 - Coverage pattern

3. INSTALLATION

3.1 DIP Switches Setup




Figure 3 – Battery Insertion

Remove the 2 detector's bottom covers (see Figure 3, steps 1-5) to gain access to the DIP switches. Set the DIP switches as follows:

DIP SW #	Function	Description	Default
1	Alarm LED OFF/ON	OFF: Motion and masking alarm LED is disabled (OFF). ON: Motion and masking alarm LED is enabled (ON).	ON
2	24H / night only	OFF: Motion alarms are always enabled (24 hours). ON: Motion alarms are enabled only at dark (night).	OFF
3	AM ON /OFF	ON: AM enabled OFF: AM disabled	ON

3.2 Battery Insertion (Figure 3)

It is recommended to perform the first batteries insertion on a desk. Upon battery insertion, the LED will flash for 30 seconds and then the detector will enter into 15 minutes walk-test mode.

3.3 Enrolling

Enroll the detectors into the alarm system's memory as described in the alarm system installer guide – ENROLLING section. When you are instructed to initiate transmission from the detector. Activate the tamper switch, i.e. open the detector bottom cover (see Fig. 3, steps 1 - 3) and then close it or remove & reinsert the batteries.

3.4 Installation





Figure 4 - Installation

- Bracket installation (see figure 4) – firmly fix the bracket on a stable wall or pillar. The orientation of the fixed bracket should be as parallel as possible to the surveyed ground surface.
- Adjust detector's vertical and horizontal angles (see Fig. 5), according to the surveyed ground surface. The vertical angle indicator position for various installation height and coverage distance combinations is detailed in table 1 (the information refers to a relatively flat surveyed area. however, in any case the vertical adjustment should be verified by walk-test).
- Fasten the detector to the bracket (see Fig. 4 step 4).

3.5 Cover Closure (see Fig. 5, steps 7-11)

3.6 Test

- Set the detector in Walk-Test mode, as follows:
Open the detector bottom cover (see Fig. 3, steps 1 - 3) and then close it. The LED will flash for 30 seconds and then the detector will enter into 15 minutes walk-test mode.
Note: The detector automatically enters into 15 minutes walk-test mode after battery installation or Tamper switch recovery.
- Walk into the detector's field of view at the expected far edge of the coverage area. Verify that each time your motion is detected the LED lights for 2 seconds and the control panel receives the alarm. If required, perform detector's horizontal / vertical readjustments.
Important! Instruct the user to perform walk test at least once a week, to verify proper operation of the detector.
- Place a piece of cardboard on the detector's front side, to deliberately mask the optical window. After 2 minutes, the LED should flash for 5 seconds (see table below) and the alarm control panel should receive the masking alarm.
- Remove the masking from the detector's front side. The LED should extinguish (after a few seconds).

LED operation:

Event	LED Operation
First 30 sec after battery insertion, or closing the detector cover	slow flashing
Mask detection (*) (**)	fast flashing 5 sec.
PIR detection	2 sec. ON within 15 min.
(**)	2 sec. ON after 1st detection ***

* The LED flashes fast continuously during walk-test mode (15 min.).

** LED ON/OFF control by DIP switch #1 (see par. 3.1).

*** After 3 detections the detector disables itself to save battery power. Further detection is possible only if no movement occurs during the following 2 minutes. The detector will revert to the initial state if there is no movement for an additional 2 minutes.
